

ENTRY GUIDELINES • 2021 RFA JURIED ONLINE SHOW • FEBRUARY 26th – MAY 26th, 2021

ENTER: Complete the online entry form found at <https://www.rocklinfinearts.org/2021-juried-show/entry-form/> and upload your image(s) as instructed. Payment is accepted online or by mail. See instructions on the entry form.

ENTRY DEADLINE: Entries and payment must be received by **midnight, February 16, 2021.**

ELIGIBILITY: Open to all artists 18 years of age or older.

ELIGIBLE WORK: All work must be original in any media. This includes, but is not limited to, the following categories: OIL, ACRYLIC, WATERCOLOR, PASTEL, PENCIL, CHARCOAL, PEN & INK, COLORED PENCIL, MIXED MEDIA, ALCOHOL INK, ENCAUSTIC, CASEIN, PHOTOGRAPHY, FIBER ART, CERAMIC, FUSED & BLOWN GLASS, 3D & SCULPTURE. Entries must be appropriate for viewing by all ages (G-Rated). Work must not have been shown at any previously sponsored RFA events. Non-original classwork, giclée and/or prints are not acceptable. All entries are juried. If artwork is not accepted, artists will be notified. Entry fees are non-refundable.

AWARDS: First, Second, and Third Place prizes of \$100, \$50, and \$25 will be awarded in several different categories. One Best in Show prize of \$100 and one Honorable Mention prize of \$25 will also be awarded. Art will be juried and ranked by category to determine final awards. **RFA reserves the right to determine award categories based on number of entries in categories listed above, and/or combine categories if necessary.**

ENTRY FEES: \$25. 00 First Entry • \$20.00 each additional entry. Payment must be received/postmarked by February 16th at midnight. Checks payable to Rocklin Fine Arts. Credit cards accepted online. **Once an entry is submitted, no artwork substitutions or changes are allowed. NO REFUNDS.**

IMAGES:

- **File Format:** Send a .jpg (jpeg). or .png (ping) formatted in RGB (red/green/blue) color.
- **File Resolution:** 300 dpi to 600 dpi (dots per inch). Each image will have an enlarged close-up view, so the original image you send needs to be high resolution.
- **File Size:** at least 3MB (megabytes), especially if sending images from a cell phone. Your email host may limit larger file sizes, so a range of 3 MB to 5 MB is good for online purposes.
- **Crop** images to a rectangle and do not include extraneous background, matting, or frame.
- Use appropriate lighting to avoid glares. Thin vertical images do not show well online.
- Cell phone images are fine if sent at highest resolution (at least 3 MB or more).
